## COVID-19 Contact Tracing Scams

Sterling, Colo. – August 11, 2020: You have probably heard a lot about contact tracing, which is the process the Northeast Colorado Health Department (NCHD) uses to contact people that have tested positive or been exposed to someone with COVID-19, instructing them to quarantine or isolate and monitor their symptoms daily. However it has come to our attention that scammers, claiming to be employees of the health department are either texting or calling residents asking for personal information or money.

*“We have heard from the public that scammers are calling people saying they are from the health department trying to get people's private financial information and/or requesting money for their test results,” stated Trish McClain, Director of NCHD. “This is very concerning and I want to make sure the public is aware that we would never ask for money, their financial information or social security information.”*

Case investigation and contact tracing for Logan, Morgan, Phillips, Sedgwick, Washington and Yuma counties are conducted by NCHD employees who are listed in our full staff directory located at <https://www.nchd.org/contact>. For NCHD, case investigations start with a phone call to patients who have recently been tested positive for COVID-19. The investigator will discuss who they may have been interacting with recently, help with isolation plans for themselves and resources they may need while in quarantine. Individual information is not shared and all information collected during interviews is used only to track the spread of the disease.

Interviewers operate under strict confidentiality rules and collected data is protected in secure systems. Investigators will need names and phone numbers for those people who are identified as close contacts while the patient was possibly infectious, but they will never ask for personal information like immigration status, marital status, Social Security, bank account, or credit card information. Anyone who does, is a scammer.

*Mike Burnet, NCHD 's Response Coordination Officer remarks "Contact tracing plays a vital role in stopping the spread of COVID-19. Scammers, pretending to be investigators, are taking advantage of that system, damaging our reputation and the trust of our community."*

These scams are both texting spam messages that ask to click a link, or by a phone call where the person asks for money to pay for testing. NCHD is not currently contacting anyone by text messaging. Legitimate calls received from authorized tracers will not ask for payment or personal financial information over the phone.
