**GENERAL STATEMENT OF DUTIES:**

The Communities That Care (CTC) Youth Advisor works with a dynamic community-based program known as Communities that Care (CTC) at Northeast Colorado Health Department to reduce substance misuse among youth. The Youth Advisor should be willing to work with the Wray Community using evidence-based community organizing approaches to reduce the risk of and increase the protective factors which are also linked to long-term reductions in violence and suicide (in addition to substance misuse). Additionally, the Youth Advisor will work with NCHD to guide the Community Board from a youth standpoint.

**PRIMARY DUTIES:**

*The CTC Youth Advisor position may not include all of the duties listed, nor do the listed examples include all tasks which may be found in positions of this class. The CTC Youth Advisor will assist with engaging community members, especially youth, for supporting the community coalition groups to understand and implement the Communities That Care (CTC) Model. This position will encourage the use of evidence-based approaches as the local Coalition plans, develops, implements, monitors, and sustains prevention strategies aligned to community needs.

This role will make an impact at NCHD and in the community through the following activities:

- Strategically collaborates on program goals with Coalition Members, and community partners (youth, healthcare, law enforcement, public education, elected officials, etc.)
- Attend CTC's various work group meetings to address youth needs and provide expertise.
- Engages with community members and organization to facilitate youth-adult activities.
- Reports back to the Youth Board.
- Help plan, set up and attend community presentations or events.

**QUALIFICATIONS:**

A successful Youth Advisor will have the following traits and abilities:

- Experience with living or working in Wray area.
- Strong work ethic and passion for community health.
- Experience with social media preferred.
- Willingness to give presentations and speak publicly.
- Willingness to complete professional development trainings.
- Must be between the ages of 16 and 24 years old.
- Must be able to work four (4) hours per week. (Hours may vary)
